- *Note:* Last Will and Testament "In the name of God amen I Michael Luther Snr of Randolph County and State of North Carolina being weak in body but sound of mind and perfect memory blessed be almighty god for the same do make and publish this my last will and testament in manner and form following that is to say first I give and bequeath unto my beloved wife Mary and my son Daniel and daughter Deborah and Salome and Anna all my Lands and tennaments together with my stock of horses, cows, sheep, and hogs and household furniture to be kept together during the life of their mother and after her death to be Equally divided between the four. I also give and bequeath to my son Michael and Godfri and Abraham and Jonathan Luther and Barbara Wooleaver the sum of five shillings cash and I hereby appoint my beloved wife Mary and my son Daniel Luther sole Executor of this my Last will and testament hereby Rescuing all former wills by me made in witness whereof I have her unto set my hand and seal the twenty fifth of June in the year of our Lord one thousand eight hundred twenty three signed sealed published and delivered by me the above named Michael
