**Petition**, 17 Sep 1888. A. C. MCALISTER is guardian of Rosaline, age about 36 years old, lunatic, who lives with her brother, Nathan LOFLIN, who cares for her, but is poor. Guardian wants to use her estate for her support, to be paid to her brother.

**Affidavit**, 20 Sep 1888, of T. B. ELLIOT(T) in support of above petition.

**Final decree**, 21 Sep 1888. Guardian may pay Nathan LOFLIN \$12 yearly.

**Guardian account**, 14 April 1889.

**Final guardian account**, 28 Oct 1892.

**LOFLIN, IREDELL - 1855** (only 1 paper in folder)

**Executor's account**, May term 1855. 2 pp. Robert LOFLIN, executor. Account primarily lists notes held on different folks, including: Owen GALLIMORE, Wyatt NANCE, John COSHATT, Fred<sup>k</sup> YATES, Wm. GILES, Noah GADDIS, John & Robert LAUGHLIN.

**LOFLIN, RICHARD & JOHN - 1844**

**Power of attorney**, 17 Aug 1805 (29<sup>th</sup> & 30<sup>th</sup> years of Independence). Willis (X) HIX, Isaiah (X) HIX, Wm. HALL, James TARPLEY, Wm. (X) HIX, Benj. (X) BROTHERS to Davis HIX. (I would guess this is misfiled, but don't know where it should go.)

**22 March 1841**, Timothy GRIFFIN certifies that he sold his part of the land where Thomas BYRNS now lives and asks to have a deed of sale made.

**List of articles** allotted widow Molly LOFLIN for year's support. No date.

**Account**, no date. This lists a lot of buyers of whisky.

**List of property & notes**, 27 Nov 1843. 2 pp.

**List of sale**, 19 Dec 1843. 4 pp. Buyers included: Wm. & Joel COGGIN, Timothy GRIFFIN, Eleazar LOFLIN, Wm., John & Cornelius VARNER, Sarah HIX, Johnson FRY, Zack YARBOROUGH, Kincher STOKES, Levi HILL, Joshua NAILOR, John SAUNDERS, Claiborn CRANFORD.

**12 Feb 1844**, Davidson Co. Richard LAUGHLIN is deceased, and Davis HICKS obtained administration - has leave to take possession of estate.

**Account** of proceeds from sale, 11 May 1844.

**List**, 22 Feb 1846. H. ANDREWS to G. C. MENDENHALL, atty., of Larrenceville, NC. Gives a list of the children of John & Cornelius LOFLIN, dec'd.

**Bill of complaint**, to Spring term 1846 (2 copies of this). Davis HIX, admin. vs. heirs & Hez. ANDREWS. He wants to make settlement, but needs a list of advancements made in Richard's lifetime. Estate was small, only about \$200, except for a slave, which some heirs filed petition to sell at Davidson Co. Court May term 1844. The deft. Hezekiah ANDREWS was appointed commissioner and sold the aged male slave for \$270, and now holds the proceeds, being advised to do so due to some irregularity in the sale. Heirs are: (their residence comes from the memo, which follows)

3. Winney - married Jesse HILL - IN

5. Sarah - married Timothy GRIFFIN
