Memo to file Bill, no date. Says Richard died 1 Dec 1843. Negro was named Luke. (listed heirs & residence)

Oath, 26 March 1846, of Davis (X) HICKS that some heirs are non-residents.

Power of attorney, 13 April 1846, Carroll Co. Georgia. (Sawney) INGRAM to Wm. LOFLIN of Randolph Co. NC. (Looks like it was addressed to LOFLIN at Mt. Lebanon, Davidson Co.)

Order for Master's report for accounting of Richard's estate in the hands of his administrator, including the amount in the hands of H. ANDREWS. No date.

Oath of Timothy (X) GRIFFIN that NEWBY, LUTHER, SHAW, INGRAM & others are non-residents, and order for advertisement, 9 Feb 1847.

Order, no date, of advertisement for six weeks in the *Greensboro Patriot*. Hezekiah ANDREWS appointed guardian of the minor children of Cornelius LOFLIN

Account, 1847. Richard LOFLIN to Lemuel SMITH for making shingles.

Answer of Hannah (X) VARNER, 27 Mar 1848. Says most of the children got more than she did. The land her father gave her, she & VARNER sold to Jesse HILL after about ten years.

Notice, 6 May 1848, to VARNER, GRIFFIN, & ANDREWS that J. WORTH, clerk & Master, will execute order of reference.

Affidavit, 6 May 1848, of Geo. C. MENDENHALL, atty. Admits that slave Luke was sold for \$270, with \$10 allowed to H. ANDREWS for making the sale.

Bill of cost, 23 May 1848.

Inventory, 7 Sep 1848, of property given Rebecca (X) HIX by her father.

Answer of Eleazer LOFLIN, and answer of Timothy (X) GRIFFIN, 18 Sep 1848. GRIFFIN says the notes referred to in Eleazer's answer were given Richard by his sons-in-law for money lent to them over and above advancements.
