I was interested in the family members who, fought, and died for the Confederacy. I was unable to determine a Keeran/Kearns in my line, who participated in the Revolutionary War.

In our research it was determined that there are numerous small towns in Ireland with the In our research it was a Kilkieran in County Galway, Kilkerrin in County Roscommon, Kearns sounding name, such as Kilkieran in County Galway, Kilkerrin in County Roscommon, Kearns sounding many West Meath, Drumkeeran in County Sligo, Killkeeran in County Mayo, Ballykeeran in County West Meath, Drumkeeran in County Sligo, Killkeeran in County Mayo, Ballykeeran in County Waterford, and Kilkieran in County Kilkenny. This is a good indication that the Kearns Clan was exceptionally visible in Ireland.

Centuries ago, even before the English, Irish and Scots settled in America, there was an ancient group of people in Iberia (Central Spain) called Celts. The Celts migrated to what is today called group of people in the Celts spoke the Gaelic language, which did not contain the letter "K," Ireland, and Scotland. therefore the Kearns spelling today does not resemble the Gaelic spelling. The Gaelic spelling of the Kearns name was O'Cieran and O'Ciarain, which was prominently found in the Irish Counties of Mayo, Cork, and Claire. In 1465, the English passed a law that each Irish male was required to anglicize his last name, thus eliminating the Gaelic spelling, and using the alphabet, as we know it today. The former Celtic spellings were anglicized to Kieran, Keeran, Kerin, Keron, and Kearns, and any other name that carried the sound of the name. The changes in spelling are primarily attributed to English law, lack of education, and human interpretation.

An example of how names have changed over time is reflected in our Kearns name. In 1700, our first Kearns family, Thomas and Sarah Keeran living in Pennsylvania had at least three known sons, John, Thomas, and William. The three sons pronounced, and spelled their last name as Keeran. The three sons married, and moved to different states. John's descendants who moved to North Carolina began spelling their last name from Keeran to Kearns in the early 1800's. Thomas's descendants, who moved to Virginia did not change the spelling of their name, and even today use the original spelling of Keeran. William's descendants, who moved to Maryland, eventually changed the spelling of their name from Keeran to Kerns.

In about 432 A.D., Saint Patrick arrived in Ireland. Shortly after his arrival, Saint Kieran, an Irish Saint and Catholic Priest, was recognized as a prominent figure. St. Kieran (Kearns) was known throughout Europe. He was born about 512 A.D. in Cape Clear, southwest Cork. He founded the Clonmacnoise Monastery, near Moate, and Athlone on River Shannon in 547 A.D. Our Kearns genealogy begins in the same general area of Moate, and Athlone. Legends attribute St. Kieran with remarkable miracles. St. Kieran died in 549 A.D. as a result of a plague of epidemic proportions.

There have been several other prominent individuals in Ireland with the Kearns family name. The tomb of Teige O'Kerin (1685) is still to be seen in Ennis Abbey in County Claire. Another prominent person was Catholic Father Moses Kearns, who was hung from a lamp post in Paris in 1788 by a revolutionary mob. Fortunately he survived when the pole he was hanging from

Descendants of Unknown (Kiernan) Kearns

Generation No. 1

1. Unknown (Kiernan) Kearns was born Bet. 1675 - 1700 in probably Offaly or Dublin County, Ireland. 1. Unknown (St. 1695, daughter of Simon Hadley and Catherine Talbot. She was born Abt. 1671 in Moate, West Meath County, Ireland

Notes for Unknown (Kiernan) Kearns:

Irish Records do not reflect the first name of the first known Kearns ancestor, therefore he will be referred to as Mr. Kearns. Other family members of Mr. Unknown Kearns, and the Jane Hadley family have conducted research in Ireland, and concluded there is no evidence this family immigrated to America. The first recorded Kearns immigrating to America is Thomas Kearns, son of Mr. Kearns, and Jane Hadley, who is mentioned in the will of his uncle, Simon Hadley II, Delaware County, Delaware.

The Keerans have been traced to Kings County, Ireland, now Offaly County, Ireland. Mr. Keeran, and Jane, a Quaker, moved with the Hadleys to Moate, West Meath County, Ireland about 1700. It is recorded in Moate MM that Jane, and her mother Catherine, were members of the Quaker movement.

The earliest record of a Keeran family member is that of Jane (Hadley) Keeran. She was dismissed from the Moate MM in West Meath County, Ireland in 1702. The dismissal clearly states her husband, (Mr. Kearns) was not a Quaker.

Notes for Jane Hadley:

Jane Hadley's family should be recognized, because they are an important part of the Keeran / Kearns Genealogy. Jane's father, Simon Hadley I, descended from land proprietors of Hadleigh of Somerset, England. He was born about 1640, and migrated to northern Ireland when King James I sent English, Scottish settlers, and colonists to settle the plantations, which were seized by the Crown, when Britain declared the rebellious Celtic Chiefs guilty of treason. The Simon Hadley I family was reported to be of wealth. Jane became a Quaker, and moved to the Moate MM (Quaker) in West Meath County, Ireland about 1702. Jane married out of the Quaker faith, and her father, Simon I, was criticized by the Quakers, because he approved of the marriage. Jane married Mr. Keeran, who was believed to be Catholic. Jane's grandparents were James Hadley and Jane Roswell.

Simon I married Catherine Talbot about 1659. The first records of Simon I, and his wife Catherine are in 1672, Dublin, Ireland. She was the first in the family to become a member of the Society of Friends (Quaker Religion). She attended the appearance of William Penn when he visited the "Ulster" to spread the Friends word.

In 1680, Simon I owned land of Manor of Chantarfe, and this is believed to be in the Dublin area. It is mentioned by one historian this is on a river. The records of the Office of Arms, Dublin Castle states Simon I petitioned Parliament about 1680, for protection against possible confiscation of his property, should the area be forfeited to the Crown, as was threatened.

A family historian states Simon I owned iron works in Kings County, Ireland, and a Fishery in Dublin. It is thought he spent his last years at Ballinakill, just north of Kilkenny in Queens County, now Laois County, or near Tullamore in Kings County, now Offaly County, between Tullamore and Dublin. Since Jane and Simon II married into the Kearns family, it is believed the Kearns lived in the same area.

Children named in Simon's will were John, Elizabeth Miller, and Jane Kiernan (Keeran). Simon II. was not named in the will, and it is assumed he had already received his patrimony, before departure to America.

Evidence indicates Jane Hadley Kearns to be the sister of Simon Hadley II, a member of the Friends Church, and resided in or on the border of Chester County, Pennsylvania, and Delaware County, Delaware. I have not been able to attach Ruth to the Keran family, however I surmise Ruth married into the Kearns family. Jane's brother, Simon II and his wife Ruth Miller Keran, were seen in America about 1710. Between the years 1709-1715 there was a large number of Irish "Friends" known as Quakers who immigrated to this country.

Moate MM records state Catherine Hadley, wife of Simon Hadley I, died 20 April 1710. She was seventy at death, making her birth about 1640. Simon died 6 June 1711 at the age of seventy, making his birth about 1641. Jane was listed in the will of her father, dated 1711.

Simon was reprimanded for his military activities, and later disowned for marrying out of unity to his second wife, Elizabeth, after Catherine's death. Moate MM records reflect that Simon I apologized for his conduct.

The following notes from Lyle Hadley book, page 5:

"In 1710, Simon Hadley, the elder, came to dwell in our neighborhood after the wars, by too much indulging his children, and his carelessness in religious matters, it appeared he had little more than a shew of religion which he was admonished, and instead of receiving exhortation, and practicing the same, he desired to be left alone, and in about three weeks after the death of his wife, who was a woman of good repute in the area, he being about seventy years of age, and was married."

The following article was published in The Pennsylvania Gazette 24 November 1757:

"All Persons indebted to the Estate of Simon Hadley, Esq.; late of Mill Creek Hundred in the County of New Castle deceased, by Bond, Bill, Book Debt, or otherwise, are hereby desired to make speedy payment of their respective Debts, otherwise they may expect to be dealt with as the Law directs, without further Notice: And those who have any Demands against the said Estate, to bring in their Accounts immediately, that they may be settled and paid by James Thompson, and John Hadley, Executors"

Simon II was born about 1675/6, probably Dublin (also mentioned, Moate, Westmeath, Ireland)), and died after 3 November 1755, probably New Castle, Delaware. He came to America about 1712, and settled in New Castle, Delaware. He married Ruth (Miller) Keran after 6 September 1697, and they were disowned by Moate MM on 8 April 1698, for marriage to a woman for whom another man had offered marriage. This took place in West Meath, Ireland. The letter of dismissal was received in America before 4 June 1716. Ruth Miller Keran was the daughter of Robert and Margaret (Brathwaite) Miller. It appears Ruth may have been first married to a Keran, and later married Simon Hadley II. This may have been the reason Simon II was disowned by Moate MM.

Simon II purchased land in New Castle County (now Delaware) about 1717, and built a large stone house, barn and outbuildings as a farmer. Part of the house on the Delaware property was still standing in the 1970's. "The old house is on a slight eminence nearly a quarter of a mile back from the road, and the nearest railway station, Southwood, is on what was once a part of the place. The house is a two and one half story stucco covered stone structure. The pointed windows under the gables give a quaint appearance to the building and along the front extends a long porch. Underneath the window in the front, a white stone slab is sunk in the wall and on it is carved "S and R.H. 1717" which indicates the initials of Simon and his wife Ruth Hadley. "Quaker records.

Ruth Keran was born December 1677, in West Meath County, Ireland, and died 18 December 1750/1. New Castle, Delaware, and buried New Garden Friends Cemetery, Chester County, Pennsylvania. Simon II was married a second time to Phebe (Grubb) Buffington, widow of Richard Buffington of Chester County, Pa.

Simon Hadley II and Ruth Miller Keran children were:

1 Joseph, born West Meath County, Ireland 25 August 1698, married Amy Gregg in Center Meeting Center 25

August 1721.

2 Deborah, born West Meath County, Ireland 25 February 1701, married Benjamin Fredd In New Garden MM, Chester County, Pa. 20 April 1721. Benjamin, born 5 September 1687, died 1752, Chester County, Pennsylvania. 3 Joshua, born 6 March 1703, died about 1760 Hillsborough, Orange County, NC, married Mary Rowland born about 1704.

4 Simon III, born Moate MM, West Meath County, Ireland 23 December 1705, died 4 November 1730/31. He was buried New Garden MM, Chester County, Pennsylvania. It is said Simon III was murdered by a servant on his farm, for the gold, he was known to carry.

5 Hannah, born 16 November 1709, West Meath County, Ireland, died 31 May 1783, and was buried Cane Creek Cemetery, Orange County, NC. She was a founding member of Cane Creek MM and her Manor House at Hillsborough was confiscated by General Lord Cornwallis, and used as his headquarters during the Battle of Guilford Court House, NC, during the Revolutionary War. She was instrumental in organizing the Cane Creek Meeting House on her farm, as a center to support the American Cause during the war, and offering passive resistance to the Tories. She married Thomas Dixon, born about 1705. He died about 1734, Chester County, Pennsylvania. She married second John Stanfield, born about 1715 from County Armagh, Ireland, and he died about August 1755, Orange County, NC. *New Castle, Delaware, notes from Quaker Collection: Hadley Line. Cane Creek Cemetery is located near a stream of the same name in Orange County, NC, and was established 7 October 1751. The Friends Meeting House is active at the original Cane Creek site, located in Alamance County, NC, near Snow Camp, about 15 miles south of Graham, NC.

6 Ruth, born between 6 December 1711/12, married 21 November 1731, New Garden, Pennsylvania. She married Thomas Lindley - born 25 February 1705/06, Cadlow, Ireland, died 15 March 1780, Hillsborough, Orange County, NC. They are reported to be buried at Spring MM Cemetery, Alamance County, NC.

7 Catherine, born 25 May 1715, Chester County, Pennsylvania., married Robert Johnson Jr., born about 1700 County Wicklow, Ireland.

8 Anne, born 7 December 1717/8 Chester County, Pennsylvania, died 18 December 1750. She married Richard Gregg - born about 1714, New Castle County, Delaware.

Simon II's will is recorded 1756, in Wilmington, Delaware (reported to be the longest will in Delaware). He disposed of \$15,000.00, and had 60 bequests.

Child of Unknown Kearns and Jane Hadley is:

Thomas (Keeran)² Kearns I, born Abt. 1712 in West Meath, Ireland; died 07 February 1796.

Generation No. 2

 Thomas (Keeran)² Kearns I (Unknown (Kiernan)¹) was born Abt. 1712 in West Meath, Ireland, and died 07 February 1796. He married Sarah Lacton/Layton November 1736 in Chester County, PA. She died 27 September 1789 in Chester County, Pennsylvania.

Notes for Thomas (Keeran) Kearns I:

It is believed Thomas migrated to Chester County, Pennsylvania about 1730 from Ireland. Since his mother, Jane Hadley Keerans, was Quaker, he became Quaker by birthright. Shortly after arriving in Chester County, Thomas signed the wedding register of the Quaker Wedding of Ann Hadley, daughter of Simon Hadley of Newcastle County, to Richard Gregg in 12 December 1735 at New Garden MM, Chester County, Pennsylvania. Ann Hadleys marriage record is listed in the Swathmore, Quaker Library in unpublished materials. *Information from Charlotte Walters Scottish Bible records, Mechanicsburg, Pennsylvania.

A report was made by Kennett MM, Chester County, Pennsylvania 3 March 1740: "Whereas complaint was made to our monthly meeting against Thomas Keeran for offering abuse to a woman which friends brought into consideration appointed some friends to inquire into the nature of the charge, and upon the whole do think him not capable to clear himself to their satisfaction which that he may come to is our sincere desire—Given forth from our monthly meeting of Newark held at Center on 5th day of November 1740."

Thomas Keeran received ten pounds as a "nephew" in the will of Simon Hadley II. Simon lived in New Castle County, Delaware, where the will was probated in 1755.

He appeared as a witness on a mortgage written in 1762 in New London Township, Chester County, Pennsylvania, which did not require him to be a resident of the county.

The William Wade Hinshaw Index records to Pennsylvania Quaker Meeting Records of Kennett Monthly Meeting, Chester County, Pennsylvania reflects Thomas Keeran was disciplined by being discovned for disunity on the 3rd March 1740. He was discovned again by the Quaker Church 15 October 1767.

The Chester County Archives, and Records Services of West Chester, Pennsylvania reflected Thomas never appeared in Chester County taxes for the indexed years 1730-1740-1750-1765-1768-1775-1785, and 1799. There are not any deeds of purchase or sale of real estate in Chester County, Pennsylvania.

Many of the Kearns children, along with their allied families were married at The Holy Trinity (Old Swedes Church) which was built in 1698 - 1699. It is presently located at 606 Church Street, Wilmington, Delaware. The area of the church was first settled when the Swedes settled the area in 1638, and used the burial ground as the site for the new church. As the foundation was being dug, and graves discovered, the foundation was shaped so as not to disturb the graves. There are over 15,000 graves in the church yard, and still active at present. The church was placed under the jurisdiction of the Protestant Episcopal Church in 1791. Old Swedes was designated a Registered National Historic Landmark 29 March 1963. Presently, it is the nation's oldest church building still standing as originally built, and still has regular worship.

THE KEERAN STORY, by Edra Keeran, did extensive research on the Kearns family, and bases much of her information from a Bible found in the home of Mrs. Bess Roberts, Ft. Wayne, Indiana, present location unknown. She believed this is the only Thomas that has been located in a logical geographic place at the proper time. She also noted John and Hannah Miller Keerans, son and daughter in law of Thomas, were believed to have gone to the Carolina's with their children Silas, and Isaac.

Notes for Sarah Laeton/Layton:

"Sarah Lacton/Layton, now Keran, married out of Friends by a priest before 6th of 4th mo, 1737, acknowledged 7th of 9th mo 1737." EARLY CHURCH RECORDS of Delaware CO., Pennsylvania. She appeared before the meeting 5 July 1737, and acknowledged her wrong doing, and was approved, and received back into membership 4 December 1737. "CONCORD MONTHLY MEETING ADDENDUM page 226.

Sarah may be the granddaughter of William Laeton, who in 1704 transacted land deeds in Goshen Twsp, Chester County, Pennsylvania.

Notes for Jane Kearns:

Jane was disciplined 3rd September 1757 by the Quaker Church for marrying out of unity (mou). It was reported Jane replied negatively to return to the Quaker services with an apology for marrying out of unity. *Marriage records - Episcopal Church, Wilmington, Delaware.

 John Thomas (Keeran)³ Kearns (Thomas (Keeran)², Unknown (Kiernan)¹) was born Abt. 1732 in Kinnett Square, Chester County, Pennsylvania, and died Abt. 01 March 1794 in Randolph County, NC. He married Hannah Miller 31 July 1763 in Old Swedes Church, Wilmington, Delaware, daughter of James Miller and Ann Cane. She was born 20 February 1736/37 in Kinnett Square, Chester County, Pennsylvania, and died in Randolph County, NC.

Notes for John Thomas (Keeran) Kearns:

The 6th of December 1762, a mortgage was issued to Joseph Cook of New London, yeoman to William Miller of New Garden, Chester County, Pennsylvania. It was delivered in the presence of John Curle, John Keeran, and T. Woodward, and recorded 10 Dec 1762 (M12:490) ABSTRACTS OF CHESTER CO. LAND RECORDS

John is listed as a Quaker in 1764. He was disciplined the 16th February 1764 for marrying contrary to discipline (Med). Again, on 12 April 1764, he was disciplined for marrying contrary to discipline (Med). Hannah, also a member of the Quaker Church, was disowned by the church, after her marriage. It appears they were living in Delaware County, Pennsylvania.

After 1768, it is believed John and family left Chester County, Pennsylvania for North Carolina. A fellow researcher mentions that John and Hannah had three children: Isaac, Silas, and Sarah.

The Quakers were not looked at favorably due to their position on slavery, and other personal positions they held. The 1700s led many Quakers migrating through Virginia, Kentucky, and the Northwest Territory.

James Miller listed John and Hannah in his will 13 June 1774, and Hannah was willed 20 pounds.

North Carolina documents reflect that Kearns, Kern, Keerans, Carns, and Karns appear in the state, beginning in 1750. The Kearns were found in seven areas of the state: Surry, Rowan, Mecklenburg, Orange, Montgomery, Johnston, and Randolph County.

John is first seen in Randolph County, NC in 1779. John Kearns listed as "Carns" in the Randolph County tax list of 1779, had a land value of 230 shillings. This is the year Randolph became a county from land taken from Guilford County. John departed Chester County, Pennsylvania about 1768, and his whereabouts are unknown from 1768 to 1779. Guilford County was established from Orange, and Rowan County in 1771, therefore John may have been listed in Orange or Rowan. In 1780, he was appointed to work on the road from his house to McKuleroy's, and the Montgomery County line.

During 1781, John witnessed a deed from Walter, and Clara Ashmore to George Wilson on Fork Creek, Richland Creek, and Deep River, Randolph County.

During 1782, he paid tax as a Quaker for being over 50 years old (probably to avoid military service), and being over 50 years of age, he was liable to pay only a two fold tax.

John appears on the 1785 Randolph County Tax List as CEARNS, and pays tax on 200 acres. He received a land grant of 465 acres from the state of North Carolina. Records reflect a Cearns listed with the preceding transaction. However, there is not enough evidence to support this is our John Kearns. He also signed a petition in 1785, to relocate the court house near the center of the county. John, Isaac and, Silas signed in a 1-2-3 sequence. He is shown in an court affidavit as a witness to a cabin burning incident 5 September 1785.

The 1790 census shows his name as John Kain, household # 728, himself, 3 males over 16, 1 male under 16, and 4 females including wife. Listed next door to John at household 727 is Silas Kean, with one listing (himself).

The September 13th, 1793 Term of Court orders John Kearns, among others, "view and lay off a road from Jesse Henleys Mill to the Montgomery line the nearest and best near Andrew Muckleroys."

Probate Records dated 11 March 1794, reflects the death of John, listing 200 pounds. On the same day, in sequence Silas, Isaac and, Hannah Kearns record cattle brands at the court house. Ann Kearns, Isaac Kearns, William Hill, and Jonathan Philips were listed and, were held and bound as the administrators of his estate.

1722 and they had 9 children. The oldest son was James, who inherited much of his father's property received from his will of 1774. He bequeathed to his daughter Hannah, wife of John Kearns, 20 pounds. James father, John, left Charlemont, Armagh County, Ireland for Moate, West Meath County, Ireland and later to America John, left of the Hadley family and others. The Miller family was of strong Quaker faith.

James, son of John and Ann, was born about 1700, in Bellybogan MM, County Armagh, Ireland, and died 3 December 1774, in New Garden, Chester County, Pennsylvania. He married Ann Cain / Kearns 24 March 1721/22, in Chester County, Pennsylvania. Ann was born in Charlemont, Armagh County, Northern Ireland. Ann Cane Miller, widow of James Miller, New Garden died 14 March 1783. She left each of her children 1 shilling each. To children of son John, deceased I shilling. To children of Ann, deceased, I shilling. To children of son Joseph, deceased 1 shilling. The 3 children of son William, Alice, Israel and Jacob 30 pounds, to be divided at age 21. To granddaughter Elizabeth Dougherty, case of drawers, to granddaughter Mary Dougherty 4 pounds at age 21. To niece of Ann, wife of John Dougherty, bedding. To granddaughter Hannah, wife of Robert Boothe, furniture. To granddaughter Deborah, wife of William Barnes, brass kettle, to great grandsons John, son of grandson William Barnes, 5 pounds. To great grandsons John, and Isaac, sons of grandson William Barns, all remainder of estate. Executor - Grandson William Barns. Proven date 23 April 1785

He moved from Chester County to the northern end of Dunmore County, Virginia, now Shenandoah County. Virginia. It is believed Toms' Brook ran through the land where he lived. Toms' Brook is about 8 or 9 miles southwest, near where Interstate I-66 intersects with I-81, due west of Washington DC. The actual farm has not been located, but believed to be west of the Interstate.

Thomas will, Volume E, Pages 352, 353 and 354, is listed in the will book of Shenandoah County, Virginia, which is located in Woodstock, Virginia Court House. His estate entered into probate in Shenandoah County, Virginia 30 April 1799 and finalized 10 March 1800.

It is mentioned, but not qualified, that Thomas wife, Sarah, maintained contact with the Society of Friends in Hopewell, Virginia.

The Kearns lived initially in Frederick County, Virginia, which later was named Shenandoah, Virginia. A family Bible reflects Thomas died 3 March 1799 at age 57, making his birth 1742. *Information may be found in a book by Wilmer L. Kerns "FREDERICK COUNTY"

He is listed in his father in laws' will, Benjamin Orin who died 14 Jan 1789. The will was listed in York County, Pennsylvania, and proved 30 March 1792 (Monaghan Twp).

The Chester County, Pennsylvania post office advertised the 12th August 1795 letters were being held for William Keeran.

The 29th of January 1823 THE CHESTER VILLAGE RECORD published the following notice. "Died on the 6th, William Kerns, a respectable citizen of East Marlborough, aged 78 years 11 months and 12 days. The deceased has born the name of an honest man, and that with propriety."

Isaac, was paid fifteen shillings in a court session for killing two wolves, March 1788. He was 22 years old when Isaac, was paid in the same session, a young attorney by the name of Andrew Johnson was practicing law in this occurred. But and on the state of the s

Isaac is listed as Isaac Kain in the 1790, age 24, US Census, household #531, with two individuals (Isaac and Rebecca). It is reported Isaac paid a tax for his father. It is believed Isaac, and his father John, were the last Kearns to practice the Quaker faith.

Isaac, and his sister Ann Kearns, along with William Hill, and Jonathan Phillips signed the estate administrative bond 11 March 1794.

An indenture was made February 1797, between Isaac and Zebedee Wood. Zebedee was chairman of the Randolph County Court. Moses Williams was to be an apprentice to Isaac, and was to be taught to read, write, and the art of farming. The date of the court order was November 1796.

Isaac purchased 103 acres from William Brookshire in 1797, and John Hill in 1803.

Isaac is listed in the 1799 Randolph County Tax List as paying tax on 1 White Poll Tax, 220 Acres, and 1 Stud Horse.

The 1800 census list 4 white males, and 3 white females, and no slaves.

Isaac purchased land in 1809, and 1813 from Sterling Hill.

The 1810 census list 6 white males, and 4 white females, and no slaves.

Randolph County 1815 Tax List reflects Isaac, Sen., listed 320, acres on Toms Creek valued at \$850.

Randolph County 1820 Tax List reflects Isaac listed 370 acres on Second Creek valued at \$850.

The 1830 census list 1 white male, age 60-70; 1 white female age 60-70, and 1 white male age 50-60.

The 1840 census list Isaac as between 70, and 80 years old, and 9 slaves.

Isaac had twelve (12) slaves when he died. The administrators of his estate were his sons: Isaac, Allen, and Jessie, and was probated in 1844.

"The Court of Pleas and Quarter Session, November term 1844, Randolph County, NC To the County Court of said County:

The petition of James Hall, and wife Hannah, John Keerans, William Jackson, and wife Charlotte Allen Kearns, Jesse Keerans, Isaac Keerans, and Frederick Goss, and wife Mary represents to your worship that in the month of October last Isaac Keerans Senior departed this life intestate, leaving your petitioners his children, and next of kin - that at the present term of this court, your worships leave grants letters of administration on the estate of the said Isaac Keerans Senior deceased to your petitioner Isaac-- that the intestate did possess of twelve slaves, to wit, Lucy, Clark, Turner, Sarah, Jarrett, Hill, and Chesley of which your petitioners are tenants in converance, and your petitioners being desirous to leave a division of the same, pray your worships to appoint three freeholders, unconnected with the parties by court anquinity of affinity to divide said slaves at nearly equally as possible, and allot to each affinity to divide said slaves at nearly equally as possible, and allot to each of your petitioners his or her share in severalty, and to report to the next term of this Court their proceedings herein

And your petitioners, as in duty bound will ever pray. J. Worth Atto. for petitioners"

The Old Kearns Cemetery is located off Highway 49. From Asheboro, NC traveling west on highway 49, turn left at the Salem United Church of Christ (black) onto a dirt road. The church is across the road from an auto salvage yard. Continue on this dirt road about one quarter mile. The road stops, turn left going down a hill, and up another to the top. On the left is a clump of trees, and old grave stones. Logging has taken place here, and the loggers have honored the cemetery, even though it is not marked. There is a large marker dedicated to William T. and Mary King Kearns. However, in my research, along with other researchers of the Kearns family have determined the listing of William and Mary King Kearns to be incorrect.

The overgrown Woods cemetery, dating back to the 1800s, is on the right side of the road leading to the Old Kearre Communication. Kearns Cemetery.

In 1775, and 1788 Silas petitioned the State Assembly to place the Randolph County seat in the middle of the county. John, Isaac, and Silas, our front runners in Randolph County, signed the petition with many of with many others in one, two, three sequence.

The 1790 census list Silas in household # 727, and only himself listed.

Randolph County Land Records reflect Silas purchasing 200 acres of land in 1805, from Harris Kimball.

The 1810 census list Silas with 5 while males, 3 white females, and no slaves.

Silas purchased land from Gabriel Henley, and James Lewis in 1814. However in 1815, he is listed without any Silas purchased fand Holl.

The Randolph County 1815 Tax List reflects Silas, Sr. with 326 acres values at \$676,

Prior to the building of the present day Salem United Methodist Church the society of Methodists worshiped at Prior to the building of the th Russell's Schoolhouse, about a quantity of the present Salem Church was constructed in 1822 by Silas, William Thompson, Thomas Nance, William Wood, and Isaac Johnson. Silas was a church trustee, and donated land, along with other church members.

The 1820 census for Silas list 1 male age 60-70, and 1 female 70-80, and the 1820 Tax List reflects Silas, Sr. with 500 acres on Toms Creek valued at \$1,200.

The Randolph Census of 1830 list Silas, and 1 female over 60, and under 70, and also listed in the 1840 census.

Silas was 74 years old when he died. The estate sale took place the 27th of August 1842. The estate sale received \$112. 21. Isaac Kearns Esq. was the administrator of the estate.

There is question as to the mother of Isaac. Jane Thompson Kearns was about 53 years old, when Isaac was born. The span of the birth of her children, as we know it, is about 23 years, which seems unlikely. Could Silas have . Silas, and Mary are listed as the parents of Isaac in the Salem Church Conference married again to Mary ____ Record, prior to 1850.

During the February 1828 term, Thomas is guardian for Isaac Ivey.

A memorial tombstone at Siloam Methodist Church, north of Denton, NC, near the Randolph and Davidson county line list the family of Thomas and Rebecca. The tombstone also list Thomas' father as John.

There is uncertainty if this is the same Thomas: Thomas Kearns of Rowan County to Ezekiel Lassiter of Randolph County 18 Oct 1822 on Tom's Creek The witnesses were P. Wood and Willie Hix \$200.00 for \$1.00 acre (200 acres).

Prisey left one Negro to Hallow increase in the Negroes in the family, her choice of one, and 100 silver dollars. Sally left furniture, and any increase in the Negroes, and her choice of one, and \$20.00

Isaac, migrated to Louisiana

Isaac, migrated to Louisiana Benjamin II born about 1800, and died about 1859 married Mary Shankle. He is buried at Zoar (formerly a Benjamin II bolil about 1969. He was left 300 silver dollars due from Marshall Nance when he comes of age.

William and his wife Mary sold to T. W. Johnson for \$75.00 an "undivided 1/24 of 3/8 interest of the tract of land, and mill property known as the Johnson Mill (which T. W. Johnson shall own a 1/3 interest, and W. T. Kearns a 1/3 interest) situated on Toms Creek adjoining the land of James K. Wood, dec'd, T. W. Johnson, and others." January 1882*

The 22nd September 1883 E. Branson Nance and wife Gracy Nance sold to William, 58 1/2 acres for \$300.00 on Second Creek.

C. L. Cranford, the great grandson of William, stated William bought property, repaired, and then sold for a profit.

His tombstone reads "My flesh shall rest in hope."

Please be advised that this only follows the 2 direct ancestral Kearns lines of James "Jamie" Arthur Johnson.

1. p. 6: There is some confusion about the ancestry of Hannah Miller Kearns. However, Sue Keirns Mulero clears it up: "1. Top of page 6, paragraph 2, It says 'James, son of John and Ann'. The name Ann should be Mary. This is just an oversight as several other places he consistently says James' wife is Ann Cain. Also there are records that confirm James m. Ann Cain. Next error. 2. He had the right numbers but just mixed them up. He writes John was born in 1693 and James was born around 1700. Actually, James is the one who was born 1693 and Ann was born around 1700. They ... married in 1722." Further, there is clarifying information in Chapter XXIX of *Our Family Ancestors* by Thomas Maxwell Potts: "John Miller, son of John Miller, born at 'Breckenbrough, in ye Parish of Kerbywilk in Yorkshire' in 1633, went over to Ireland as a planter, in 1657, and married Ann Clibborn*, daughter of William who was born in 1630, at Cowley, in the County of Durham. ...* The Clibborns are an old and well-known family of Moate and other places in Ireland" (p. 245). There children are William, Margaret, John (b. 1665 at Moate), Thomas, Abraham and Isaac (p. 245). The grandfather of Hannah Miller Kearns was John (b. 1665 at Moate) (p. 245). In the early 1700s, John and his kinfolk Gayen, Samuel and James settled in Chester Co., Pennsylvania (p. 246). "John Miller and his family [appear] to have arrived in Chester County about 1709, and settled in what is now Avondale" (p. 246). He was a Quaker (p. 246). "He married Mary Ignew, in Ireland, where some, if not all, [of] their children were born. He was elected a Member of Assembly in 1714, but died before the end of the year and before taking his seat. ... Mary Miller, his widow, died in 1730. leaving a will" (p. 246). Children of John and Mary (Ignew) Miller are James (b. 1st month, 1693 near Charlemont, County Armagh, Ireland), Mary, William, Joseph, Sarah, Elizabeth, Martha, Elinor and Susannah (p. 247). James Miller (b. 1st month, 1693 near Charlemont, County Armagh, Ireland) married "3 month 24, 1722, to Ann Cain (daughter of John and Ann), b. in County Armagh, and had children" Mary, Ann, Sarah, John, Joseph, Susannah, Hannah b. 1737, William and James (p. 247). Hannah b. 1737 is Hannah Miller Kearns. She is also mentioned in *Papers of the Historical* Society of Delaware IX. The Records of Holy Trinity Old Swedes Church, Wilmington, Del., from 1697 to 1773, p. 719, published by The

- Historical Society of Delaware, 1890; and <u>Immigration of the Irish</u> <u>Quakers into Pennsylvania 1682-1750 with their early history in Ireland</u>, p. 327, by Albert Cook Myers; and in <u>the will of James Miller</u>.
- 2. <u>p. 9</u>: Mentions that <u>C. Rebecca Webb Kearns'</u> first name was Charlotte though other sources have it as Cora. She went by Rebecca.
- 3. <u>p. 13</u>: It says that <u>Thomas Kearns</u> (b. 19 Jan. 1776; m. Rebecca Ivey) died 12 December 1847 while other sources say he died 12 November 1847.
- p. 13: It erroneously lists <u>Rebecca Ivey</u>'s (wife of Thomas Kearns) mother as Celia Forest. This has been disproven. Genealogist Bob Baird disproves this and substantiates that Sally Reese is the mother of Rebecca Ivey on pp. 23-24 of his document "<u>The Line of Adam Ivey of Charles City County</u>".
- 5. <u>p. 13</u>: It mentions Thomas Ivey (b. 1604) who married Ann Argent and migrated to America in 1625 being the parents of Adam Ivey. However, on page 5 of <u>The Line of Adam Ivey of Charles City County</u>, Bob Baird shows this is another Adam Ivey line, not my ancestral Ivey line.
- 6. <u>p. 14</u>: The death date for <u>Elizabeth "Betsy" Kearns Johnson</u> is listed as 22 July 1899, and while this agrees with some sources, other sources, including the cemetery records have 21 July 1899.
- 7. <u>p. 18</u>: <u>Silas K. Kearns</u> is listed as being born 24 December 1813, which disagrees with what's on <u>p. 23</u>, which is also echoed in other sources: 23 December 1815.
- 8. <u>p. 19</u>: <u>Margaret Jane Kearns</u> is listed as a sibling of <u>Silas Kearns</u>, but she is his daughter as proven by his will on the bottom of <u>page 1</u> and top of <u>page 2</u> where it states, "my daughter Margaret Jane Cranford". While <u>p. 19</u> correctly lists her as marrying Matthew Coggin, it fails to mention her second marriage to <u>Wenborn W. Cranford</u>. Wenborn and Margaret Cranford are my great-great grandparents.
- 9. <u>p. 23</u>: <u>Silas Kearns</u> is listed as Silas G. Keeran, and Keeran is an earlier variation for Kearns. The issue is with the middle initial G. His middle initial was K, which is proved by his will, codicil and probate document.
- p. 24: Lists one of the children of <u>Silas and Sarah (Lassiter)</u>
 <u>Kearns</u> as Margaret b. ca. 1838; m. Joshua Hurly, but Margaret married
 1) Matthew Coggin and 2) <u>Wenborn W. Cranford</u>, the latter of which substantiated by Silas' will on the bottom of <u>page 1</u> and top of <u>page 2</u> where it states, "my daughter Margaret Jane Cranford".
 - p. 27: Sarah (Lassiter) Kearns is mentioned as being born 1816, though other sources have 5 January 1815. Thomas H. Kearns is listed as the one child of Silas and Sarah (Lassiter) Kearns, but this omits their

daughter <u>Margaret Jane (Kearns) Cranford</u> as well as other children listed on <u>p. 23</u> and <u>p. 24</u>.
